# FIRST REPORT OF THE TRUSTEE ON THE STATE OF BUSINESS AND FINANCIAL AFFAIRS OF ATLANTIC SEA CUCUMBER.

I, Trevor Pringle, of msi Spergel Inc. ("MSI"), the Trustee acting in connection with the Proposal of Atlantic Sea Cucumber Ltd. (the "Company"), an insolvent person, hereby report to the Court as follows:

- On May 1<sup>st</sup>, 2023, the Company filed a Notice of Intention to Make a Proposal ("NOI") with the Official Receiver in accordance with subsection 50.4 (1) of the Bankruptcy and Insolvency Act ("BIA"). MSI consented, in writing, to act as the Trustee named in the NOI. A copy of the Certificate of Filing is attached as Appendix "A".
- 2. On May 1<sup>st</sup>, 2023, the Debtor filed with the Official Receiver the prescribed Statement indicating the projected cash flow of the Debtor ("Cash Flow Statement") in accordance with subsection 50.4 (2) of the BIA. The Cash Flow Statement, extending to the period ending October 31<sup>st</sup>, 2023, was prepared by the Company, was reviewed for its reasonableness by MSI, and was signed by MSI and the Company. Along with the Cash Flow Statement, the Company filed: (a) a report on the reasonableness of the Cash Flow Statement, in the prescribed form, prepared and signed by MSI; and (b) a report containing prescribed representations by the Company regarding the preparation of the Cash Flow Statement, in prescribed form, prepared and signed by the Company. A copy of the Cash Flow Statement is attached as Appendix "B".



- 3. On May 2<sup>nd</sup>, 2023, MSI mailed to every known creditor a copy of the NOI as required under subsection 50.4(6) of the BIA. A copy of the NOI mailing is attached as **Appendix "C"**.
- 4. The Company is, pursuant to subsection 50.4 (9) of the BIA, seeking an extension of the time within which it is required to file a proposal. This Report is being filed in accordance with the requirements of subsection 50.4 (7) of the BIA.
- Subsequent to the filing of the NOI, MSI has been monitoring the Company's financial
  affairs and for that purpose has had access to the Company's books, records, and other
  financial documents to adequately assess the Company's ongoing financial affairs.
- 6. The Company owns/operates a seafood processing plant and the place of business is located at 212 Paul's Point Road in Hackett's Cove, Nova Scotia (the "Premises").
- 7. The primary source of the Company's financial difficulties relates to a significant drop in sales due to the COVID pandemic and a \$1.6 million judgement awarded against the Company to a seafood supplier.
- 8. As of the date of this Report, the Company's significant assets consist of the following:
  - Property/Building of \$1,430,000;
  - ii. Inventory of \$1,908,094;
  - iii. Cash in Bank of \$52,279; and
  - Accounts Receivable of \$862,658.
- 9. The secured liabilities against the Company consist of the following:
  - Atlantic Golden Age Holding Inc. owed \$2,835,269.
  - ii. AP Canada Fund 1 owed \$1,593,078.
- 10. The unsecured liabilities against the Company total approximately \$3,587,323.
- 11. Prior to this application to the Court for an extension of time for filing the Company's proposal, MSI held discussions with management and made inquiries into: (a) the reasons for the need for an extension of time, and (b) the Company's conduct subsequent to filing the NOI. MSI also examined the financial performance and financial circumstances of the Company subsequent to filing the Cash Flow Statement with the Official Receiver on May 1<sup>st</sup>, 2023.
- 12. The Company is in the process of formulating a plan to maximize recovery for the creditors and continue operations.



- 13. The Company requires an extension of 45 days in order for it to be in a position to make a viable proposal.
- 14. The Trustee is of the opinion that:
  - (a) The Company has acted, and is acting, in good faith and with due diligence;
  - (b) The Company would likely be able to make a viable proposal if the extension being applied for were granted; and,
  - (c) That no creditor would be materially prejudiced if the extension being applied for were granted.


