- I am the Director of the Respondent corporations and as such, I have knowledge of the matters to
 which I hereinafter depose. Where my knowledge is based on information and belief, I have
 identified the source of such knowledge and I verily believe such information to be true.
- I make this my Affidavit supplemental to my previous Affidavit in this matter, sworn October 2nd,
 2023, in response to the Applicant's Reply Affidavit of Tro Derbedrossian, sworn October 4, 2023.

- 3. Ten 4 System Ltd.'s (hereinafter "Ten 4") May 2023 report was uploaded to the Applicant's (hereinafter "RBC") online portal on May 31, 2023. Attached hereto and marked as Exhibit "A" is a true copy of a screenshot showing the May 2023 report uploaded to RBC's Coverity Board.
- 4. Ten 4's accountant was out of the country between July and September for vacation. Consequently, Ten 4 could not provide its August and September reports to RBC. In fact, RBC was notified of our accountant's unavailability, via email. Attached hereto and marked as **Exhibit "B"** is a true copy of my email to Raman Gill of RBC, dated August 14, 2023.
- 5. It was because the 51 cheques provided by Northwest Carrier Ltd. (hereinafter "Northwest") to Ten 4 were returned due to insufficient funds that Northwest provided further cheques amounting to \$1,989,360, as referenced in my previous Affidavit (though incorrectly stated therein to be \$1,100,000), to partially cover those missing payments.
- 6. Ten 4 did not deposit the partial payment of \$720,840.57 draft from Northwest into Ten 4's RBC account because I had understood that account to have been frozen by RBC. As a consequence, Ten 4 deposited the draft into its Bank of Montreal (hereinafter "BMO") account. Attached hereto and marked as Exhibit "C" is a true copy of Ten 4's BMO account statement (appropriately redacted) confirming deposit of the \$720,840.57 on August 30, 2023.
- 7. Evidence of the payment of property taxes made by the Respondents 1000043321 Ontario Inc. and 1000122550 Ontario Inc. has already been provided in my previous Affidavit. Unfortunately, I am unable to provide the Certificate of Certified Tax from the township because this information has not been updated by the administration of the township. Notwithstanding the foregoing, I verily believe that both named Respondents are up-to-date on their property taxes.

- 8. I can confirm that as of September 30, 2023 the Ten 4 has total Accounts Receivable of \$
 Canadian dollars. Attached hereto and marked as **Exhibit "D"** is a true copy of the A/R Aging Summary of Ten 4, dated September 30, 2023.
- 9. Finally, the property owned by the Respondents 1000043321 Ontario Inc. and 1000122550 Ontario Inc. (hereinafter the "Property") is currently valued at \$ Attached hereto and marked as **Exhibit** "E" is a true copy of the Appraisal Report of the Property by Cushman & Wakefield ULC, dated October 10, 2023.
- 10. I make this Affidavit in response to the Applicant's Application to Appoint a Receiver and for no other or improper purpose.


