With the assistance of Mr Gennis and Ms. Sicard and Ms. Stubbs on behalf of the Bankruptcy Court Office, I believe that we have worked out a procedure that respects the provisions of s.41 of the BIA, recognizes that the documentation available to the Trustee from the files of the former trustees may be less than optimal and does not impose an administrative burden on the Bankruptcy Court Office.

- All of the Matters listed on Schedule A to this Endorsement (the "Estates") will be dealt with on one omnibus motion, under the Blue Sling Property Management Limited 31-226687 Style of Cause, for the purposes of setting up a Caselines event bundle, and filing materials through the Bankruptcy Portal;
- 2) All of the taxations and discharges for all of the Estates listed on Schedule A to this Endorsement shall be heard by me at a Special Appointment on October 26 at 10 AM for the full day (the "Hearing");
- 3) Given the paucity of the documentation and the age of the files, many of which have never been in the Court system, or have ever been digitized, I will deal with both the Taxation and the Discharge of the Trustee, or alleged Trustee, of all of the Estates at the hearing on October 26 under the provisions of s.41, to the extent that the state of these files permit compliance with the strict provisions of s.41, with the process amended to make compliance more practical;
- 4) The Trustee will prepare one updated Supplementary Affidavit for this matter for all of the Estates (the "Supplementary Affidavit"), as a supplement to the existing Affidavit of Alan Spergel sworn January 11, 2023 (the "Original Affidavit"), with the documentation available with respect to each Estate being exhibits to the Supplementary Affidavit;
- 5) When prepared, the Trustee will upload this Endorsement, the Motion Record with the Original Affidavit, the Supplementary Affidavit, the Notice of the Hearing and the Notice of the Hearing Materials to a website set up for the purpose of providing access to this documentation by October 6, 2023 (the "Website") which contains a link to an email box for creditors to be able to request information from the Trustee relating to these discharges and the Hearing;
- 6) If addresses of Creditors in the Estates are available in the documentation relating to an individual Estate, the Trustee shall mail a Notice of the October 26 hearing, containing the Zoom Coordinates for the Hearing as well as the IP address for the Website, to all of those creditors **by October 6, 2023** (the

- "Notice") and that an omnibus Affidavit of Service be provided with respect to the mailings (the "Affidavit of Service");
- 7) Trustee to provide **by October 23, 2023** a hard copy of the Supplementary Affidavit to the Bankruptcy Court Office and a draft Order in Word should be provided to the Bankruptcy Court Office to be forwarded to me
- 8) All of the materials relating to the Hearing should be uploaded to Caselines, **by**October 23, 2023, including any objections sent by Creditors to the Trustee;
- 9) At the Hearing the Trustee should provide information relating to the inquiries received with respect to the Estates;
- 10)Creditors shall have **until October 23** to file objections to discharge in any of the Estates in accordance with s.41(5) which will be dealt with at the Hearing.

If the Trustee requires clarification or assistance, they should contact the Bankruptcy Court Office, and I will make myself available.
