ON READING the <u>Amended</u> Statement of Claim, the Motion Record of the Plaintiffs, including the Affidavit of Janet Perkins sworn on February 14, 2020 and the exhibits referred to therein, the Supplementary Affidavit of Janet Perkins sworn March 16, 2020 and the exhibits

referred to therein, and on hearing the submissions of counsel for the Plaintiffs and the Defendants, and on noting the undertaking of the Plaintiffs to abide by any Order this Court may make concerning damages arising from the granting and enforcement of the *Mareva* injunction which is sought by the Plaintiffs,

- 1. **THIS COURT ORDERS** that pending the hearing of the Plaintiffs' motion, this matter is adjourned to a Case Conference before Gilmore, J. on June 17, 2020 at 9:30 a.m. for one hour. On that date, counsel shall discuss a revised litigation timetable.
- 2. THIS COURT ORDERS that the parties listed in Schedule "A" hereto shall prepare and provide to the Plaintiffs, and Noble House Development Corporation and 2209326 Ontario Ltd. shall prepare and provide to msi Spergel Inc., on or before July 10, 2020 a sworn statement describing the nature, value, and location of their assets worldwide, whether in their own name or not and whether solely or jointly owned unless otherwise dealt with in their materials responding to the Plaintiffs' motion.
- 3. **THIS COURT ORDERS** that paragraph 1 of the Order of the Honourable Justice Gilmore dated May 27, 2020 and attached hereto as Schedule "B" is hereby varied by adding the underlined language to paragraph 1 in that Order in the manner reproduced below:

THIS COURT ORDERS that the Canadian Imperial Bank of Commerce shall deliver copies of the bank account statements and records generated between January 1, 2017 to the date of this Order, including copies of any and all cheques, drafts or other instruments relating to deposits, credits, debits and/or withdrawals, for any all bank accounts maintained on behalf of Re/Max North Country Realty Inc., including the bank accounts bearing account numbers 08942-4574419 and 08942-4574516, to the lawyers for the Plaintiffs within fourteen (14) days of the date of this Order, subject to any reasonable requests for additional time due to the Covid-19 pandemic.

4. THIS COURT ORDERS that the costs of today's attendance shall be reserved to the judge hearing the Plaintiffs' motion.
