**THIS MOTION IS FOR:**

1. An Order discharging and releasing msi Spergel inc. ("**MSI**") as Trustee of the Bankruptcy and Division 1 Proposal Estates listed in Schedule "A" attached hereto (the "**Estates**"); and
2. An Order declaring that no action is required by MSI with respect to the bankruptcy petitions listed in Schedule "A" attached hereto (the "**Petitions**");

**THE GROUNDS FOR THE MOTION ARE:**

1. Spergel is unable to complete the administration of the Estates due to lack of records;
2. Spergel has been unable to recover records from the Office of the Superintendent of Bankruptcy, the Court, or the Archives of Ontario;
4. The Office of the Superintendent of Bankruptcy has consented to the Trustee's Motion;
5. Section 34(2) and Section 41((2) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3.

AFFIDAVIT OF ALAN HARVEY SPERGEL  
(Sworn the 11<sup>th</sup> day of January, 2023)

I, Alan Harvey Spergel, of the City of Toronto, in the Province of Ontario, MAKE  
OATH AND SAY THAT:

1. I am a Licensed Insolvency Trustee with msi Spergel inc., and President of msi Spergel inc., ("MSI") the Trustee named in the insolvency estates and the Petitions under consideration by the Court herein and as such have knowledge of the facts herein deposed to.
2. MSI has been requested by the Office of the Superintendent of Bankruptcy ("OSB") to seek a discharge of the Trustee in certain of the bankruptcy and Proposal estates listed in the Schedule attached to this Affidavit as **Exhibit "1"**.
3. The listed estates consist of the following:
  - i) 10 Ordinary corporate bankruptcies;
  - ii) 8 Annulled Division 1 Proposals;
  - iii) 2 Division 1 Proposals and
  - iv) 6 Bankruptcy petitions, none of which, to the best of my knowledge and belief have ever resulted in bankruptcy orders.
4. MSI is unable to seek and obtain its discharge of the bankruptcy estates in the normal course as documents cannot be located to enable it to do so. This is compounded by the fact that with one exception, namely the Division 1 Proposal of Alexander William

Alexopoulos ( Estate No. 32-156011) the estates included in Exhibit "1" have insolvency dates prior to 2006 and accordingly, were administered under the old ISS Software program which has not been supported since the introduction of the Ascend Insolvency Software in 2006.

- 5 I confirm that there are no open bank accounts for any of these estates and that in the intervening years since the filing dates of these estates, I have never had an enquiry with respect to any matter relating to the estates. It is my belief that the administration of the listed estates was in fact completed.
- 6 The insolvency estates in question have been the subject matter of significant effort on the part of MSI since on or about January 2017. Spergel has been working closely with the OSB in an attempt to track down documents to enable the development of a finite list of estates where the Court's intervention would be required. Exhibit "1" is the product of that effort.
- 7 By emails dated January 30, 2017 and January 31, 2017, respectively, MSI was advised by the OSB of the file status of most of the listed estates. With few exceptions, the status was the same; namely that the OSB was unable to locate the file; the file was presumed destroyed; no Statement of Receipts and Disbursements was filed, and no Trustee discharge had been obtained. Attached to this my Affidavit as **Exhibit "2"** are copies of the emails received by MSI from the OSB dated January 30, 2017 and January 31, 2017, respectively.
- 8 In addition, I am advised by Eileen Sturge, a senior estate administer with MSI, and do verily believe, that early in January 2017, she attended at the Archives of Ontario to locate documents from the Court files for a number of the Estates listed on Exhibit 1. I am further advised by Ms. Sturge and do verily believe that there were only original filing documents located.



- 9 Attached to this my Affidavit as **Exhibit "3"** are copies of Bankruptcy and Insolvency Record Searches for the corporate bankruptcy estates listed on Exhibit 1 with respect to which MSI is seeking its discharge as Trustee for the reasons described above.
- 10 As regards the Undischarged Annulled Division 1 Proposal Estates listed in Appendix 1, these were originally filed as Division 1 Proposals by Kisluk & Company Limited ("**Kisluk**"). These Proposals were annulled by the Court and the Debtors assigned into bankruptcy with Kisluk named as Trustee. Kisluk was ultimately discharged as Trustee in each of these estates, however the proposal estates although annulled remained open and were transferred to MSI pursuant to a Court Order dated January 19, 2016 (the "**January 2016 Order**"). To date, MSI has not been discharged. A copy of the January 2016 Order is attached to this my Affidavit as **Exhibit "4"** is a copy of the January 2016 Order.
- 11 Attached to this my Affidavit as "**Exhibit "5"** are copies of Bankruptcy and Insolvency Record Searches for the Annulled Division 1 Proposal Estates listed on Exhibit 1 with respect to which MSI is seeking its discharge as Trustee for the reasons described above and for the Kisluk bankruptcy estates for which Kisluk obtained its discharge.
- 12 Attached to this my Affidavit as **Exhibit "6"** are copies of Bankruptcy and Insolvency Record Searches for the Division 1 Proposals listed on Exhibit 1 with respect to which MSI is seeking its discharge as Trustee for the reasons described above.
- 13 As regards the Petitions listed in Exhibit 1, MSI takes the position that no action is required of it relative thereto as it has not been named as Trustee under the provisions of the *Bankruptcy and Insolvency Act* ("**BIA**") but has merely agreed to act as Trustee should a bankruptcy Order be issued in consequence of any of such petitions. To the best of my knowledge, no bankruptcy order has been issued under any of the listed Petitions.
- 14 The OSB is fully supportive of this Motion being brought by MSI as evidenced by the email from Marie-Josée Sicard dated January 10, 2023 which is attached to this my Affidavit as **Exhibit "7"**.

2. **AND THIS COURT FURTHER ORDERS THAT** the requirement for a separate Notice of Motion and supporting Affidavits to be filed in the Court file of each of the Subject Estates is hereby waived; *but a copy of the Order shall be filed with the court in each of the Subject Estates. / M*

3. **AND THIS COURT FURTHER ORDERS THAT** the requirement for notification of this application to proven creditors within the Subject Estates and to the bankrupts and debtors is hereby waived;

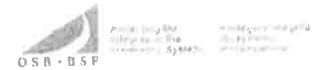
