RESELLER AGREEMENT

BETWEEN

BANNERS BROKER UK LIMITED

This Reseller Agreement ("Reseller Agreement") is made effective as of this 15th day of December, 2011, (the "Effective Date"), by and between BANNERS BROKER INTERNATIONAL LIMITED with principal offices located at 100 King Street West, Suite 5700, Toronto, Ontario, M5X 1C7, and Banners Broker UK Limited, a corporation with principal offices located at Botanical House15 Guys Cliffe Road, Leamington Spa, CV32 5BZ ("Reseller").

1. TERMS AND CONDITIONS

- 1.1.1 This Reseller Agreement will remain in effect for a period of one year (the "Initial Term). Thereafter, the Reseller Agreement will be automatically renewed for successive three-year renewal terms unless earlier terminated as provided herein.
- 1.1.2 Notwithstanding the foregoing, the Reseller Agreement may be terminated prior to the expiration of the Reseller Agreement as follows:
- 1.1.3 The Reseller may terminate this Reseller Agreement at any time by written notice to that effect given not less than ninety (90) calendar days prior to the date on which the termination is to become effective;
- 1.1.4 Banners Broker Reseller hereby agrees that it will not sell and/or distribute any competitor's products and/or services in competition with BANNERS BROKER INTERNATIONAL LIMITED for a period of 12 months following the termination of this Reseller Agreement.
- 1.1.5 BANNERS BROKER INTERNATIONAL LIMITED may terminate this Reseller Agreement at any time provided that it has notified the Reseller in writing a minimum of three times of violations the Reseller may be in breach of. Banners Broker International Limited may also terminate this agreement if the Reseller has not hit agreed upon sales volume within six months of the agreement of volume.
- 1.1.6 Either party may terminate this Reseller Agreement immediately upon written notice if the other party:
 - (a) makes an assignment for the benefit of creditors or becomes insolvent;
 - (b) files for protection or relief under the bankruptcy laws of India;
 - (c) has a receiver, trustee, custodian or other official appointed for all or substantially all of such party's assets;
 - (d) fails to operate as a going concern for more than twenty (20) calendar days.

8. CONFIDENTIALITY: PROPRIETARY INFORMATION; BUSINESS RECORDS
